# Knowledge Sharing and Thought Leadership - Academic Conference, Thought Leadership Summit, and Practitioner's Workshop

- 1. **Second Sustainability, ESG, and Value Creation Conference**: Held in Niagara Falls on October 11-12, 2024, this conference was a collaborative effort by three CPA Ontario Centres at McMaster University, University of Waterloo, and Brock University. It featured 13 paper presentations and discussions by scholars from prestigious universities worldwide. The conference focused on the debate over mandated sustainability disclosures, exploring their necessity, cost-benefit analysis, and global regulatory impacts. It further explored the social and financial impacts of climate-risk disclosures and the corporate biodiversity footprint.
- 2. **2024 Practice Seminar:** "Accounting, Markets and Real Estate Industry": Hosted at McMaster University on April 9, 2024, this seminar featured Judy Marsales, CEO and Owner of Judy Marsales Real Estate Ltd. She provided unique industry insights and inspired innovation. The seminar aimed to support DeGroote School of Business research and foster collaboration between academia, industry, government, and CPA members.
- 3. **First Accounting Thought Leadership Summit**: Held at the Ron Joyce Centre, McMaster University, on April 13, 2023, this summit brought together three corporate leaders to speak to students and CPA members. The event included a panel discussion on business challenges and corporate leadership, aiming to enhance DeGroote School of Business research and promote thought leadership within the CPA
